

# **Employee Gifts & Benefits Register**

The Local Government Act 1999 requires that gifts and benefits received by Council Employees be recorded on a register, which is made publicly available on Council's website.

For the purposes of section 119A(2) of the Local Government Act 1999, the threshold amount governing when a gift or benefit must be registered is gazetted at \$50 (notice appeared in the Government Gazette No. 79 on 17 November 2022).
