Indemnity

Use, operation and maintenance

- The hirer agrees that the use of the Giant Games carries with it dangers and risks of injury and the hirer agrees to accept all dangers and risks.
- The Coorong District Council will "stock take" the equipment just before its departure from the site and again on its return
- COVID-19 Requirements: The hirer agrees to return the Giant Games clean and disinfected.

Loss, damage or breakdown of plant and equipment

- The hirer will be responsible for any loss or damage to the Giant Games and equipment irrespective of how the loss or damage occurred (fair wear and tear excepted) during the hire period. The replacement cost of the Giant Games Set is \$1,500.00. If any items from the Giant Games set are lost/not returned then the hirer will be responsible for the cost of replacement and freight of those items.
- If there is a breakdown or failure of the equipment then the hirer shall return the equipment to the owner at the hirer's expense and the hirer shall not attempt to repair the equipment.

Liability

 The hirer will assume all risks and liabilities for and in respect of the equipment and for all the injuries to or deaths of persons and any damage to property howsoever arising from the hirer's possession, use, maintenance, repair or storage of the equipment.
